

**NORTHWEST INDIANA SWIM CONFERENCE  
CHAMPIONSHIP MEET  
FEBRUARY 17-19, 2012**

- SANCTION:** This meet is sanctioned by USA Swimming, Inc. and Indiana Swimming, Inc. with the Indiana Sanction #IN12166.
- SPONSOR:** Northwest Indiana Swim Conference
- LOCATION:** Wheeler High School, 597 W. 300 N. Valparaiso, IN 46385 Enter through main doors on east end of school.
- FACILITIES:** Six (6) lane, 25 yard pool with starting blocks, non-turbulent lane markers and automatic timing system with (2) back up timers per lane. Pool depth ranges from 4 feet to 13 feet. Bleacher seating is available in pool area. Adjacent locker rooms, concessions are available. Anyone caught in an unauthorized area of the school will be asked to leave the premises immediately and for the rest of the meet.
- The competition course has not been certified in accordance with USA Swimming Rule 104.2.2C(4).
- RULES:** Current USA Swimming and Indiana Swimming Rules will govern this meet. USA Swimming Rules 202.3.2- At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.
- “Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement. “
- In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.
- ELIGIBILITY:** Swimmers must be registered with USA Swimming to be accepted into the meet. Age as of February 17, 2012, shall determine the swimmer's age for the entire meet. This meet is open only to members of clubs of the Northwest Indiana Swim Conference. Indiana Swimming does not process on-site athlete registration.
- A cutoff of 10% over the Divisional time standard is in effect for events 200 yards or longer. Proof of achievement is required for missed cuts. If proof cannot be shown, there will be a \$5.00 fine, if paid before the end of the meet; or a \$6.00 fine after the meet. If the fee is not paid within 30 days, the offending club will be assessed an

MEETING:**

The coaches meeting will begin at the end of the third warm up sessions with the meet beginning immediately following the fourth session. At least one representative from each team must be present at the meeting.

Coaches **MUST** constantly display their USA Swimming coaching credentials to gain deck access. The meet referee reserves the right to ask for a coach to display credentials and / or deny deck access if the coach does not comply or card is no longer valid/current.

Host team will run and man a Clerk of the Course for all 8 & Under events.
