

**MUNSTER SWIM CLUB**

- SANCTION:** This meet is sanctioned by USA Swimming and Indiana Swimming.  
**Sanction Number #IN10044**
- HOST:** Munster Swim Club, Inc.
- LOCATION:** Munster High School, 8808 Columbia Avenue, Munster, Indiana 46321.
- FORMAT:** Current USA Swimming and Indiana Swimming rules will govern this meet.  
*USA Swimming Rules 202.3.2 - At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision. Timed finals.*
- TIMELINE:** **This is a meet for younger swimmers and it is our intention to run a festive meet with emphasis on fanfare! In addition to a “Parade of Champions” at the beginning of the meet (bring your team banners!), there will be a Team Spirit Competition (details will be sent to all teams accepted into the meet), and an awards podium decorated with balloons for the athletes. The timeline for each session includes several breaks for awards presentations.**
- ENTRY PERIOD & PROCEDURE:** Entries will be accepted starting Friday, January 1, 2010. The entry deadline will be 11:59 p.m. on Friday, January 15, 2010. We will extend the deadline if the meet is not full. All entry packets must be submitted via email (preferred method), U.S. Mail, or other delivery service. **NO HAND DELIVERIES OR TELEPHONE ENTRIES WILL BE ACCEPTED.** Email entries should be sent to: [Matthewwalee@comcast.net](mailto:Matthewwalee@comcast.net). Participants will receive a return email confirmation upon receipt of the Hy-Tek Team Manager file. Please note that this confirmation only acknowledges receipt of the file, not acceptance into the meet. The email entry must be followed up by a hard copy of the entry information, and submission of the hard copy prior to the entry deadline date would be appreciated. If not using email we recommend using FedEx, UPS, or other delivery service.
- ACCEPTANCE CRITERIA:** Entries will be accepted primarily in the order that they are received, but the number of officials provided by a club will also be considered. No teams will be broken, but entries will be limited to keep within the 4-hour rule. We will notify teams being turned away by phone or e-mail within 72-hours after the meet entry deadline, or 72-hours after meet becomes full, whichever comes first.

**SWIM SUIT**

**LEGISLATION:** **10. EFFECTIVE (OCTOBER 1, 2009) USA Swimming Swim Suit Rule (102.9.1 B) wording shall be added to all meet letters**

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

**ENTRY**

**FORMAT:**

**The following must be submitted by the entry deadline:**

- Hy-Tek Meet Manager file for entries (on 3.5” diskette). A printed copy of the entry must also accompany the diskette. All times must be completed to the hundredth of a second. No times will be accepted;
- Team Roster with each swimmer’s current USA Swimming number. Unattached swimmers must be entered independently of attached swimmers;
- Completed team summary report (included in this packet);
- Completed relay entry sheet (included in this packet);
- Executed release and hold harmless agreement (included in this packet);
- **Officials Volunteer Sheet;**
- 1 check for payment of all entry fees made payable to **Munster Swim Club, Inc.**

**IMPORTANT REMINDERS**

- **Data on disk must be consistent with the data on the print out(s).**
- **We will NOT accept hand delivered entries.**
- **Unattached swimmers must be entered independently of attached swimmers.**

**ENTRY**

- LIMITATIONS:** Swimmers will be limited to 3 individual events per session, and 5 individual events and 1 relay for the meet. If more than 5 individual events are entered, the last event(s) will be dropped. No refunds will be issued to over-entered swimmers. Entries will be limited to keep within the 4-hour rule; however, no teams will be broken.
- ELIGIBILITY:** Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of February 1, 2009, will determine the swimmer's age for the entire meet. USA Swimming registration numbers must accompany the entry.
- CHECK-IN:** This is a **POSITIVE SIGN-IN MEET**. Positive sign-in means, "I'm here. I intend to swim." To sign-in positively, circle the swimmer's name on sign-in sheets. Sign-in sheets will be posted 30 minutes before the start of warm-ups for the morning session. **The morning deadline for positive sign-in will be 8:15 a.m.** At that deadline, the sheets will be removed from the wall and no changes or corrections will be accepted for the morning session. Any swimmer scratched under this rule may present to the Referee at least 2 minutes before the start of the slowest heat of the missed event and request to swim in an empty lane. The Referee will honor such requests on a first come, first serve basis and only to the extent empty lanes are available. All swimmers who sign in for the morning session will be considered signed in for the afternoon session. **Those swimmers who did not sign in for the morning session will also be scratched from the afternoon session unless they sign in with the Clerk of Course prior to 12:40 p.m.**
- CLERK OF COURSE:** Although this invitational will be pre-seeded, a standard Clerk of Course will be operated during the meet. Please note: positive sign-in is a requirement for all age groups. Since this is a meet for younger swimmers we highly encourage coaches to cover check-in, scratch and meet procedures with their new swimmers and parents. **Absolutely no parents will be allowed on the pool deck.** This is a requirement of USA Swimming.
- FINAL RESULTS:** One complementary copy will be provided to each club entering 5 or more swimmers. You may order additional copies for \$8.00 each.
- FACILITY:** 6 lane, 25 yard pool with starting blocks. Colorado timing with two (2) back up timers per lane. Keifer non-turbulent lane markers. Adjacent locker rooms.
- COACHES:** Information packets will be distributed to the club coaches upon their arrival at the meet. A Coaches' meeting will be held 15 minutes before the start of each session. Coaches **MUST** constantly display their USA Swimming coach credentials to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if the coach does not comply.
- SCORING:** We will be scoring the top 12 individual places in the following age groups: 6 & under, 7 Yr. Old, and 8 Yr. Old. The 100 Individual Medley and 100 Freestyle

events will be swum together but will be scored separately. Relays will not be scored, but will receive awards in the 8 & under age group as set forth below. Scoring will be as follows:

Individual events: 16-13-12-11-10-9-7-5-4-3-2-1  
 Relays: None

**AWARDS:** Individual Events: Ribbons will be awarded for first 12 places in each age group.

Individual High Point: Trophies for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place to girls and boys in each age group. Swimmers' relative placement in the 100 Yard Individual Medley will be used to break any ties in the high point standings.

Relays: 1<sup>st</sup> through 6<sup>th</sup> Medals.

**CONCESSIONS:** Refreshments will be available in the concessions stand located adjacent to the pool.

**NOTES:** **ONLY COACHES AND PARTICIPATING OFFICIALS ARE ALLOWED ON THE POOL DECK. NO FOOD IS ALLOWED ON THE POOL DECK. SMOKING IS NOT PERMITTED ANYWHERE IN MUNSTER HIGH SCHOOL.**
