

UNION TOWNSHIP SWIM CLUB
IMX SNOWFLAKE CLASSIC
JANUARY 22nd, 23rd, and 24th, 2010



Sanction: This meet is sanctioned by USA Swimming and Indiana Swimming through the host, Union Township Swim Club. Sanction No. IN10165.

Meet Format: Age groups will be scored: 8 & under; 9-10; 11-12; 13-14; 15 & over. Relay age groups: 8 & under; 9-10; 11-12; 13-14; 15 & over. 13 & Over events will be scored 13-14 and 15 & Over. 500 and 1650 will count towards high points in your age group. The 1650 Free will be limited to four heats total. The 500 Free will have at least 12 heats and the 200 Frees will have at least 4 heats each but may be limited from any more because of the 4 hour rule. We will have as many as the time line will accommodate. Refunds will be given to all swimmers whose events were cut because of time line restrictions or not making the cut. All events are timed finals.

Facility: 6 lane, 25 yard pool with starting blocks. Daktronic timing. Adjacent locker rooms. Bleachers in pool area.

Rules: Current USA Swimming and Indiana Swimming rules will govern this meet. USA Swimming Rules 202.3.2 - At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision. In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Location: Wheeler High School, 587 W. 300 N., Valparaiso, IN 46385. Enter through Main Door, on East side of building.

Entry Deadline: **Entries will be accepted starting December 19, 2009. Entry deadline will be January 8, 2010. Teams not accepted will be notified by 8 P. M. January 9, 2010. No teams will be split.** We will extend deadline if meet is not full.

Fees: \$2.50 per Individual Event. \$6.00 per Relay. \$1.50 per swimmer Indiana Swimming surcharge. Fees must accompany entry forms. Please make 1 check payable to **UTSC**. Entry fees for scratched events are non-refundable. **No deck entries.**

Heat Sheets: No admission will be charged. Heat sheets will be available for \$5.00 each.

Entry Format: The following must be submitted by the entry deadline:

- HYTEK COMMLINK the file for entries (on 3.5" diskette). A printed copy of the team entry must also accompany the diskette. All times must be completed to the hundredth of the second. **NO TIMES WILL ONLY BE ACCEPTED IF SWIMMER HAS NEVER SWUM EVENT AT ANY AGE. EXPERIENCED SWIMMERS SHOULD ENTER TIMES;**
- **E-mail entries will be taken with a hard copy and check to follow;**
- Team roster with each swimmers current USA Swimming number. Unattached swimmers must be entered independently of attached swimmers;
- Completed team summary report (included in this packet);
- Completed relay entry sheet (included in this packet);
- Executed release and hold harmless agreement (included in this packet);
- Officials and Timers Volunteer Sheet, Officials and Timers would be appreciated.
- 1 check for payment of all entry fees. Make check payable to UTSC.

IMPORTANT REMINDERS

No NT's unless swimmer has never swum event before at any age. No deck entries. No entries will be changed, modified or accepted after January 21, 2010.

Data on the disk must be consistent with the data on the print out(s). Unattached swimmers must be entered independently of attached swimmers. Teams of 5 or more swimmers not submitting their entry on diskette or email will be charged a \$50.00 Administration Fee.

Entry Limitations: There will be a limit of two (2) individual events on Friday and five (5) individual events and one (1) relay per day on both Saturday and Sunday. Entries will be limited to keep within the 4-hour rule, however no teams will be broken.

Eligibility: Entrants age as of January 22, 2010 will determine meet age. All swimmers must be currently registered with USA Swimming; applied for will not be accepted. USA Swimming registration numbers must accompany the entry. All coaches on deck **must** be registered with USA Swimming and wear credentials visibly at all times to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply.

Check-In / Scratch: This is a **POSITIVE SIGN-IN MEET**. Sign-in sheets will be posted 30 minutes before the start of warm-ups. The **deadline for positive sign-in will be 30 minutes before the scheduled start of the sessions on Friday, Saturday and Sunday A.M. & P.M.** At that deadline, the sheets will be removed from the table and no changes or corrections will be accepted. Any swimmer scratched under this rule may present to the Referee at least two minutes before the start of the slowest heat of the missed event and request to swim in an empty lane. The Referee will honor such requests on a first come, first serve basis and only to the extent empty lanes are available. Failure to swim an event, after signing in, will result in being automatically scratched from the next individual event. **THIS WILL BE A CARDLESS MEET WITH NO CLERK OF COURSE.** UTSC members may be on deck to help stage the 8 & unders.

Final Results: One complimentary copy will be provided to each club entering 5 or more swimmers. You may order additional copies for \$5.00

Coaches: Meet programs will be given out upon arrival. Heat sheets will be given out to club coaches upon availability, after scratches, before the beginning of each session. A Coaches and Officials meeting will be held fifteen (15) minutes before the start of each session.

Scoring: We will be scoring the top 12 individual places and the top 3 relay places. Scoring will be as follows:
Individual Events: 16-13-12-11-10-9-7-6-5-4-3-2
Relays: 32-26-24

Awards:
Individual Events: 1st - 12th ribbons
Individual High Point trophies for 1st, 2nd, and 3rd place to girls and boys in each age group.
Relays: 1st - 3rd ribbons
Team: High Point trophies for 1st, 2nd, and 3rd places. (Host team ineligible)

Concessions: Concessions will be available on all 3 days. Coaches and Officials need to show credentials to enter lounge.

Note: Only Coaches and participating Officials and Timers are allowed on the pool deck. No food is allowed on the pool deck. **Smoking is not permitted anywhere on school property.**
