Rules: Current USA Swimming and Indiana Swimming Rules will govern this meet. Coaches MUST constantly display their USA swimming coach credential to gain deck access. The meet referee reserves the right to deny deck access if a coach does not comply.
USA Swimming Rules 202.3.2 - *At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down.*

Swimsuit Rule: **All 12 and under swimmers participating in a meet sanctioned by the Indiana LSC must comply with the new swimwear rules passed into legislation by the 2008 Indiana Swimming House of Delegates.** This legislation modifies USA Swimming Rule 102.9.1 as follows:

- A. Swim suits worn by 12 and under males participating in all Indiana Swimming sanctioned "age group" competitions will not extend above the navel or below the knees.
- B. Swim suits worn by 12 and under females participating in all Indiana Swimming sanctioned "age group" competitions will not cover the neck, extend past the shoulders; extend beyond the shoulder, nor below the pelvis.
- C. Swimsuits worn for competition must be non-transparent and conform to the current concept of appropriate.
- D. The referee shall have the authority to bar offenders from the competition until they comply with the rule.

Informational Note: Additional language to clarify that 12 & under swimmers participating in senior events are not subject to this provision is not needed because of the following articles:
Rule 205.4: AGE GROUP ELIGIBILITY - *A swimmer must compete in the age group events corresponding to the swimmer's age except when competing in consolidating events, mixed classification events and in events combined by the referee.*

Rule 204.2: SENIOR ELIGIBILITY – *All registered swimmers are eligible to compete in the Senior Class.*

Directions: **If you are coming from the Indy area:**
Follow I-74 West to Exit 34, SR 231 South (Many hotels are near this exit.) *This road is re-named Washington Street as you drive through downtown Crawfordsville. Turn RIGHT on South Boulevard at the National Guard Armory. Bear LEFT onto Highway 47 (toward Waveland); Crawfordsville High School will be on your left in ½ mile. The Aquatic Center is located on the right hand side of the building.

If you are coming from the Lafayette area: Follow SR231 South. Then use the directions after the * from above.

- Facilities:** Eight lane, 50-meter pool for competition, with additional space for continual warm-up and warm-down. Pool depth ranges from 9 feet to 3.5 feet. Colorado automatic timing system with touch pads at start and turn ends, backup buttons, and 8-lane scoreboard. Balcony seating for 500 spectators overlooks pool. Concessions will be available. A swimmer camping area will be set up in the auxiliary gym adjacent to the pool. Swimwear and equipment sales will be provided by Kast-A-Way Swimwear.
- Spectators:** Per USA Swimming Rules and insurance regulations only athletes, registered coaches, certified officials volunteering to officiate and meet volunteers are allowed on the pool deck. Balcony seating for 500 spectators, parents and family members overlooks the pool. **Due to limited seating SCSC requests that coolers, folding chairs and other large items not be taken into the balcony.** These can be set up in the auxiliary gymnasium area.
Spectator Admission Fees: Adults - \$3 per session; Children under the age of 14 - Free of charge
- Eligibility:** Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of June 30, 2009 shall determine the swimmer's age for the entire meet.
- Limit:** Entries will be limited to 600 Swims.
Each swimmer may enter **4 individual events**.
- Entry Fees:** \$4.00 per individual event. Make checks payable to Sugar Creek Swim Club. An additional \$1.50 Indiana Swimming surcharge will be collected per athlete. Fees must accompany entry. Deck entries, if accepted, will be double the regular fee.
- Awards:** Ribbons will be given for the first 8 places in each individual event. Individual High Point winner in each age group will be awarded and the top two visiting teams will receive trophies.
- Scoring:** Individual Events: 9-7-6-5-4-3-2-1 points. **NOTE:** Swimmers age 10 and younger swimming in 12 & under events **WILL NOT** be scored separately.
- Clerk of Course:** Eight and under swimmers must report to the Clerk of the Course to learn their lane assignments and be lined up to swim the event. For all other events, there will be no Clerk of the Course. Seeded heat sheets will be posted on deck immediately before the start of the meet. It is the swimmer's responsibility to appear at the correct starting block ready to swim in time for the start of his/her heat.
- Schedule:** Warm-up:
4:00-4:25 pm - Warm-up for 9 and older - NO DIVING - all 8 lanes
4:25-4:35 pm - 50-meter sprints with starts.
4:35-4:55 pm - 8 & under general warm up - NO DIVING - all 8 lanes
4:55-5:05 pm - 50-meter sprint with starts
5:15 pm – Meet Starts

Check In: This is a **POSITIVE SIGN-IN MEET**. Positive sign-in means, "I'm here. I intend to swim." To sign in positively, highlight swimmer's name on sign in sheets. The **deadline for positive sign-in will be 45 minutes before the start of each session**. At the deadline, the sheets will be removed from the wall and no changes or corrections will be accepted. Swimmers who do not sign in will be scratched.

Entry Format: The following must be submitted by the entry deadline:

- HYTEK Team Manager Meet Entry Export for Meet Manager for all entries. **Times should be submitted in Long Course Meters**. No times and nonconforming times will be accepted, but will be seeded slowest. Hand entries will be allowed; however any team with 4 or more swimmers with individual events **MUST** submit entries on disk or include a \$50.00 entry data input fee to SCSC with entry check.

If you submit your entry by email you must also send by regular mail:

- Completed team summary report and executed release and hold harmless form (included in this packet)
- Check for payment of all entry fees made out to Sugar Creek Swim Club.

If you submit your entry by mail, please include:

- Hard copy printout of your entry file that will be the basis for resolving any problems regarding that entry.
- Completed team summary report and executed release and hold harmless form (included in this packet)
- Check for payment of all entry fees made out to Sugar Creek Swim Club.

Deadline: Entries will be accepted starting: 8:00 am June 2, 2009. Entry deadline will be 5:00 pm June 16, 2009. We will extend the deadline if the meet is not full. No faxed or hand delivered entries will be accepted. In the event of a full meet, teams not accepted will be notified by 6:00 pm, June 18, 2009 at the email or phone number of the official supplying the entry. If the meet is over-entered, SCSC has the sole discretion in determining which entries to accept. Criteria we will use in making this decision include but are not limited to: balance of age groups and gender in entry, level of competition, geographic diversity, time-line of the meet.
